## **President's Report**

- Spring Registration was initially 488 players
- COVID cancelled the following divisions: T-Ball, Powder Puff, A & AA Baseball, Minor Softball and Challenger based on the BOD evaluation of the safety of players/families of each division and the recommendations/requirements from the Berkeley County Health Department.
- Thanks to everyone for their understanding and specifically the Berkeley/Morgan county Health Department for helping us through building our league guidelines and getting many players on the field for a Summer League.
- Summer Ball had 17 teams with 185 players.
  - Baseball : 2 Junior, 7 Major, 3 AAA
  - Softball: 1 Junio, 4 Major
- All Stars: Baseball had 1 team ply in the WV District 6 10-12 Special tournament.
- Tournaments hosted: Baseball District 6 Special Tournament (2 games), a weekend travel baseball tournament on the high field (2 weekends)
- Field Projects: Not many projects outside of maintenance due to tight funds due to refunds from the Spring.
  - $\circ$   $\;$  The concrete halo project on the Junior/High school field completed.
  - Built a berm at the baseball complex to move water runoff past the batting cage to prevent flooding
- Fall Ball: 11 baseball teams 2 Rookie, 3 Minor, 3 Major, and 3 Junior
- Vandalism: There was several incidents throughout the summer: graffiti at the minor where we have to repaint the dugouts and fire in the concession stand Men's bathroom that required extensive repairs.

## **New Business**

Josh Oldham made a motion to bring back Absentee Ballots that was striken from the Constitution in 2019 due to pandemic and family emergencies. 2<sup>nd</sup> by Sarah Cooper. Motion Fails with a 20 to 21 vote.
